footprint, sustainable development, biodiversity and climate change.

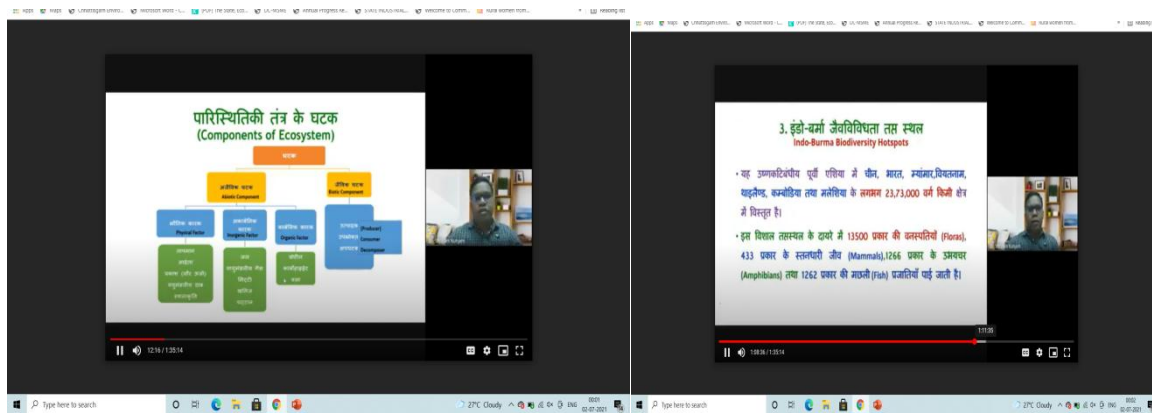

RESEARCH ACTIVITIES

The Department of economics understands the importance of research, especially for the development of the local place and people. Therefore, the department as a research Centre takes most of its research work keeping in mind the local needs. The research work includes the study of the gram panchayats of the Durg district, studies about the contribution of gram panchayats in development. Similarly, the research Centre has taken up the study of the Baigajanjati and their livelihood means. The department research Centre not only caters the local issues but also takes studies related to women empowerment, whether it's MNREGA's contribution in women empowerment or the status of Muslim women in Durg district. Durg district being the paddy growing area, many studies have been taken up related to the agriculture policies impact of FasalBimayojana or minimum support price to paddy. The studies on the public distribution system have also been undertaken. Studies on self-help group and its contribution in economic empowerment of rural people has been undertaken.

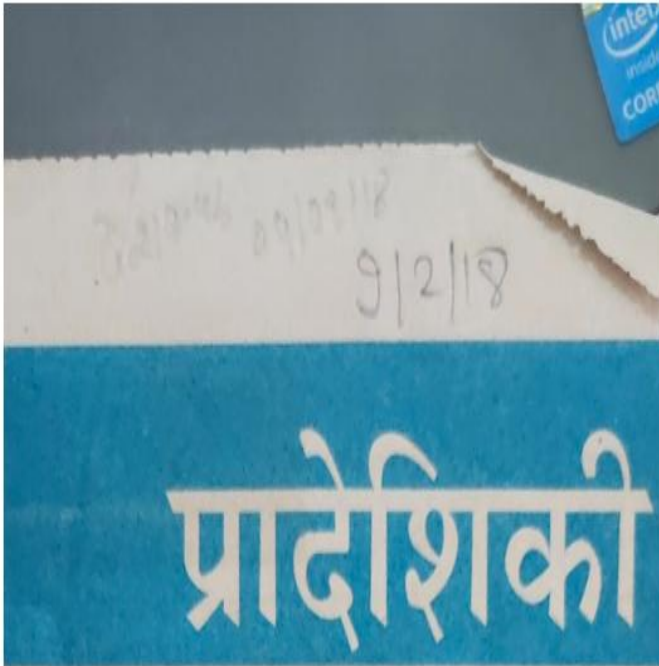
